THE PASTOR

Dear Parishioners:

I want to give you a little progress report on the Bishop's Annual Appeal. As of September 8, St. Andrew parishioners have pledged \$176,533 toward our goal of \$210,134. That is 84% of our goal. It is unusual that we are at this stage in the month of September – but this has been a very unusual year. Nevertheless, I am impressed at how quickly our parish has responded to the appeal this year in very difficult circumstances. I wish to thank all those who have already made a pledge or a contribution to the Bishop's Annual Appeal, and I want to urge those who have not done so, and who are able, to make a pledge at this time. I believe that we will be able to reach and exceed our goal this year. I remind you that any refund we may receive from this year's appeal will be used for our video system for the live streaming of our Masses. Thank you again for your amazing generosity!

I also want to bring to your attention some other causes that are asking for our help and assistance. Recently, Hurricane Laura has caused major destruction in Louisiana and other states. And at the same time, numerous severe wildfires in California and

other Western states have caused much destruction and hardship. Both of these disasters have destroyed people's homes and devastated entire regions. The United States Conference of Catholic Bishops has asked that a special collection be taken up to assist with the recovery from these disasters. The proceeds will be directed to Catholic Charities USA for this purpose. I am therefore designating the weekend of September 26-27 as the time for this special collection. Your donation may be placed in the special collection baskets in church or you may make a contribution via online giving or deliver it to the parish office. In all cases, your donation should be clearly marked for "Disaster Relief."

Finally, the annual "Good Friday" collection for the Holy Land was rescheduled for this Sunday, September 13, because there were no public services on Good Friday this year. Nevertheless, many of you have already donated to this collection during Holy Week. However, we will still accept your donation for this cause through the second Sunday of October.

I thank you, again, for your charity and generosity and I ask God's blessing upon you all.

- † All Mass Intention requests should be made in writing and must be accompanied by payment. While you may call or email to check the availability of certain dates or times, requests will not be finalized and will not be reserved until payment is received.
- † A \$10 stipend, as determined by Diocesan policy, is to accompany each Mass request.
- † Only one intention (person) per Mass is permitted, however, for pastoral concerns to better accommodate the needs of parishioners, two first names (David & Catherine Smith) or two last names (Davis & Smith Families) are acceptable.
- † Once scheduled, we will send a list of the Masses scheduled for your records. Please allow 5-7 days.
- † Families may schedule up to twelve (12) Masses per year with four (4) of those on weekends. Additional Masses will be accepted, but these will be scheduled when dates are available throughout the year on a rotating basis.

WHY DO WE DO THAT?

Catholic Life Explained
Cremation & The Church

As the practice of cremation becomes more and more common, it's important to know what the Church asks of families who have chosen this for a loved one who has died.

As the US Bishops observe on their website, "Ideally, if a family chooses cremation, the cremation would take place some time after the Funeral Mass, so that there can be an opportunity for the Vigil for the Deceased in the presence of the body." However, if cremation takes place before the Funeral Mass, the cremated remains can be present at the Funeral Mass and the appendix to the Order of Christian Funerals provides adaptations for the texts and rituals that are part of the Funeral Mass and the Committal.

The primary concern is that the cremated remains should be treated with the same respect given to any human remains. The Order of Christian Funerals instructs, "This includes the use of a worthy vessel to contain the ashes, the manner in which they are

carried, and the care and attention to appropriate placement and transport, and the final disposition. The cremated remains should be buried in a grave or entombed in a mausoleum or columbarium. The practice of scattering cremated remains on the sea, from the air, or on the ground, or keeping cremated remains on the home of a relative or friend of the deceased are not the reverent disposition that the Church requires" (no. 417).

It is becoming more and more common for parishes or diocese-sponsored cemeteries to include columbaria to house cremated remains in a way that respects Church teaching, allowing family and friends the opportunity to honor the remains of the one they have lost with dignity, reverence, and care.

IMPORTANT INFORMATION ABOUT UPCOMING PSR CLASSES

PSR for students in **Grades 1-5** began **Wednesday, September 9th**.

Classes start remotely at 4:30 p.m. Catechists have been advised to alter the length of their classes according to grade levels.

Classes for grades 6th, 7th and 8th will begin today **Sunday, September 13th** and will start remotely at 6:30 p.m. and will normally last 40 minutes.

Middle School Youth Ministry will also be remote.

Grade levels are scheduled on various Sundays for Youth Ministry—please consult your

calendars. Youth Ministry will also begin at 6:30 p.m.

Catechists at each grade level have contacted their students remotely to connect them to their virtual classes. If you have not received this information, please contact the Office of Religious Education at 614-451-2855.

Registrations for PSR are still being accepted. Parents have the option of enrolling their student for remote learning or home schooling with these exceptions:

Students in second grade preparing for First Reconciliation and First Communion are to be catechized within community—that is within the group that is preparing for First Communion. The same is true for Confirmation in 8th grade.

If you are planning on home schooling your child—that is, teaching them yourself, you are required to use materials provided by the Religious Education Office and there is a nominal fee for the materials and the home schooling process of \$125.00. You should complete the regular registration forms, send them in and we will contact you to pick up the materials you need.

GOSPEL MEDITATION
Encourage Deeper
Understanding of
Forgiveness

What right do we have to limit the amount and degree of forgiveness we show to others when we are so desperately in need of it ourselves? In not wanting someone who hurt us to downplay or forget the gravity of their wrong, we cling to anger, resentment, and wrath as a way of maintaining control. It is a way to acknowledge and express our deep hurt. We fail to realize that in doing so, we hold ourselves hostage to these destructive feelings and actually become mired in the bondage of sin. All we gain is further alienation from ourselves, others, and especially God. We are no longer free, but tethered to all of this unresolved negativity. Don't we really want to let it go? The fact is that we need to.

A good self-reflective posture will quickly show us that when the shoe is on the other foot and we are the ones in need of forgiveness, we desire it above anything else. This is especially true with our relationship with God. It is hypocritical to want one thing for ourselves and something else for another. Yet, many act in precisely this way.

Perhaps we think that in offering forgiveness, even for the most grievous of wrongs, somehow excuses the person of their wrong and makes it almost acceptable. This is what makes revenge, retaliation, and punishment so attractive. We see forgiveness as being an eraser that easily wipes away the offense without consequence. Or, we may believe that in offering forgiveness I must somehow forget the wrong and open myself as a victim of even greater possible hurts in the future. In fact, forgiving my sister or brother of their wrongful actions or attitudes involves none of this. It does not erase anything or position me vulnerably as a doormat to be walked on.

Forgiveness is an act of freedom that restores honest dialogue, shares true, and heartfelt feelings and acknowledges the consequences of an action. It admits that the wrong has caused a hurt that must be healed and squarely positions responsibility on the offender. The act of forgiveness recognizes our sinfulness and brokenness. It also admits that the most saintly among us is capable of doing very grave and deep harm to another person. It sees that we all can be victims of our passions and works in progress that deserve unlimited chances to get it right. With forgiveness, I release myself from the bonds of negativity and pursue a path of restoration, wholeness, and healing. I do not forget the wrong nor do I dismiss it. Sometimes, we have to stay far away from the one who hurt us. But we can still heal internally and be free.

For the one who wants to be forgiven and the one who needs offer forgiveness, the journey can be an adventure in learning what brought us to this place and what is needed to move forward. This is exactly how God treats us. Why would we not want to do the same for others?
